Every day, in every corner of the commonwealth, Agency 229 is making a positive impact on people's lives.

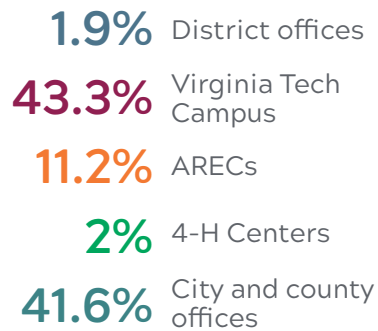

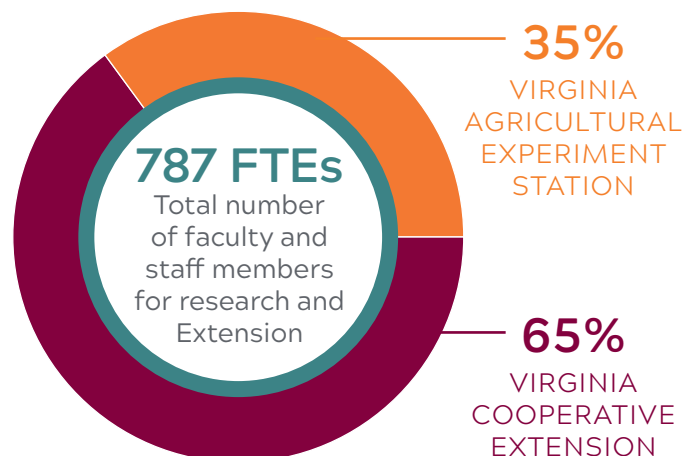
LOCATION OF RESEARCH AND EXTENSION PERSONNEL

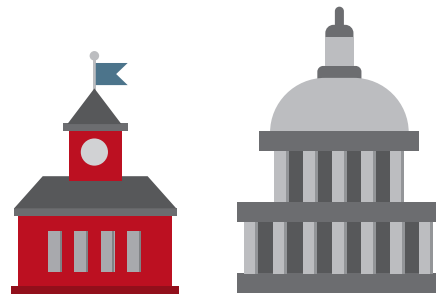
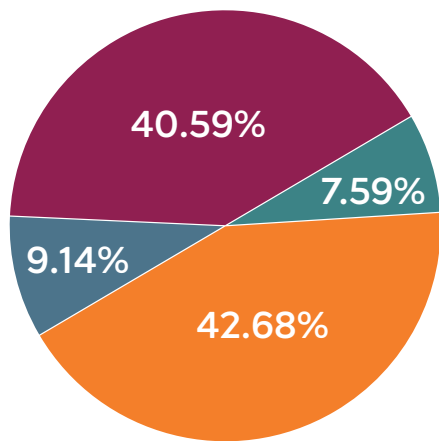
VIRGINIA AGRICULTURAL EXPERIMENT STATION

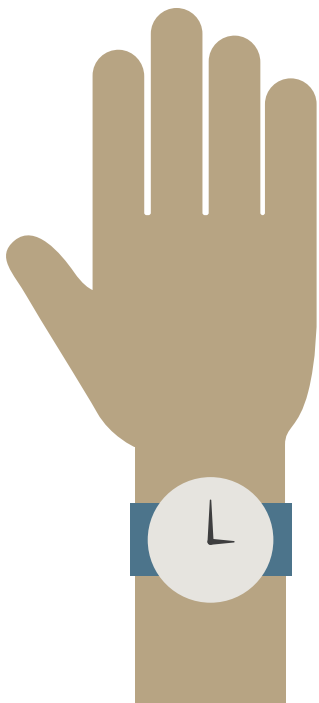
EXTENSION AND RESEARCH FUNDING

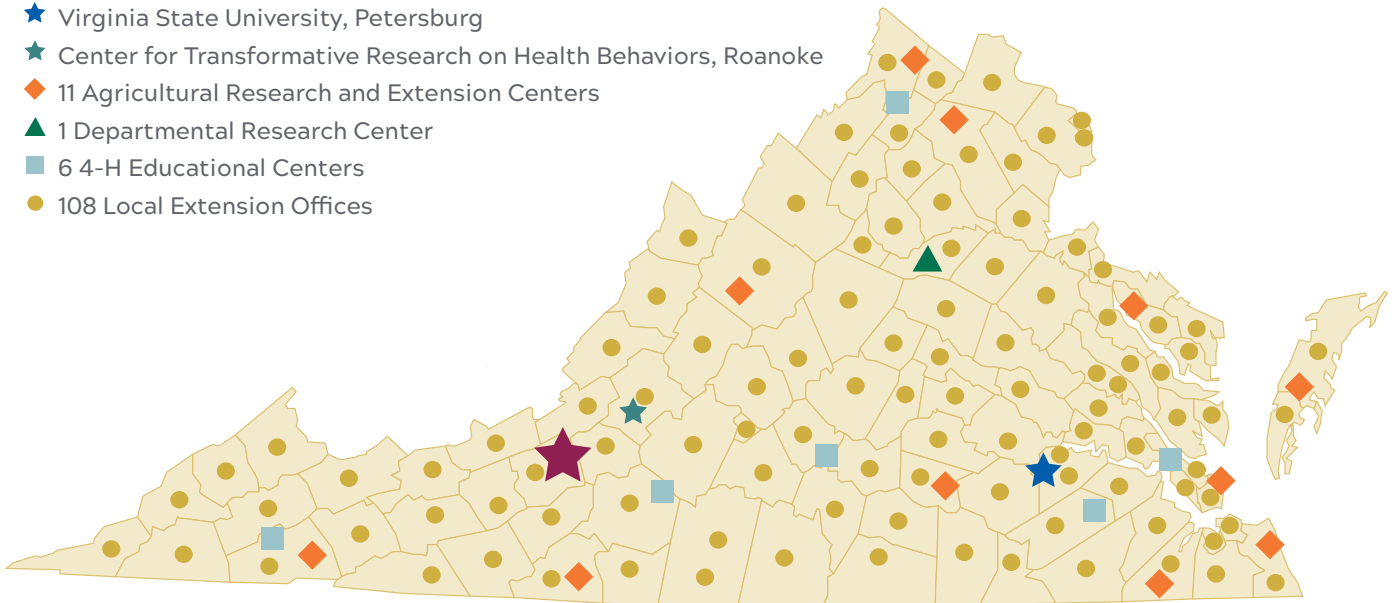
